Session Schedule & Creative Team

Every Roaming Studios session is thoughtfully curated, but travel is naturally unpredictable. Our schedule is intended as a guide and may change due to weather, local conditions, safety, availability, government requirements or other circumstances beyond our control.

Where possible, our contingency plans will provide alternative activities, workshops or locations of comparable quality to ensure your experience remains inspiring and enjoyable.

We work with a carefully selected community of artists, creatives, hosts and local guides. If a featured artist, workshop facilitator or host becomes unavailable, Roaming Studios reserves the right to appoint a suitably qualified replacement. Such changes will not be considered grounds for cancellation or refund.

Activities will be led by experienced and qualified local guides. Throughout your experience, you'll also be supported by an English-speaking Roaming Studios host.

Terms & Conditions

1. Booking Confirmation

Your booking is confirmed once:

- Roaming Studios receive your completed online booking form;
- your \$400 USD non-refundable deposit is paid;
- you receive a confirmation email from Roaming Studios; and
- you provide proof of comprehensive travel insurance at least 60 days before your session.

Bookings are accepted on a first-come, first-served basis and are subject to availability.

2. Deposit

A \$400 USD deposit is required to secure your place.

The deposit is non-refundable and non-transferable and contributes to planning, studio hire, local suppliers, artist bookings and administration.

3. Final Payment

The remaining balance is due 120 days before your session begins.

Payments are made in **USD** via our Wise Business bank account unless otherwise advised.

Roaming Studios will send reminder emails, however if payment is not received by the due date, Roaming Studios may cancel your booking and release your place. The deposit will not be refunded.

4. Minimum Bookings

Each session requires a minimum of participants to proceed.

If minimum numbers are not reached, within 90 days of session start, Roaming Studios may cancel or reschedule the session. You may choose to transfer to another session or receive a full refund of payments made directly to Roaming Studios. Roaming Studios is not responsible for any third-party costs, including flights, accommodation or visas.

5. Booking Changes

Requests to change your booking or transfer your place will be considered where possible but cannot be guaranteed. Additional costs may apply.

6. Participant Cancellation & Refund Policy

If you choose to cancel your booking:

- Your **\$400 USD deposit is non-refundable** and non-transferable.
- 120 days before the session, the remaining cost is due.
- If you cancel 90 days or more before your session: You will receive a 75% refund of payments made, not including the deposit.

- 60–89 days before your session: You will receive a 50% refund of all payments, not including the deposit.
- 59 days to 1 day before your session: No refund will be provided.

We strongly recommend purchasing comprehensive travel insurance that includes cancellation cover. Please read your policy carefully.

7. Roaming Studios Cancellation & Refund Policy

If Roaming Studios cancels your session (other than under the Force Majeure clause), you may choose to:

- transfer to another Roaming Studios experience; or
- receive a full refund of all payments made directly to Roaming Studios.

Refunds do not include flights, accommodation, visas, travel insurance or any other third-party expenses. We strongly recommend purchasing comprehensive travel insurance that includes cancellation cover.

8. Duration

The dates shown include the days of Arrival and Departure. Neither are full days. We start at 10am on Day 1 and Finish with a farewell dinner on Day 10.

Roaming Studios are not responsible for any consequences of delays or change in schedules of airlines, trains, or public transport, or personal transits of a Participant's personal travel to the Studio location.

9. Force Majeure

Roaming Studios is not liable for delays, changes, cancellations or additional costs resulting from events beyond our reasonable control. This includes, but is not limited to, natural disasters, severe weather, pandemics, government restrictions, political unrest, strikes, transport disruptions or other unforeseen events. It is the participant's responsibility to check their Government's travel advisory for current relevant information. Where possible, we will offer an alternative schedule, reschedule the session or provide a credit or refund where appropriate. Roaming Studios is not responsible for third-party expenses such as flights, accommodation or visa costs.

10. Photography & Media

Photography and video may be captured during Roaming Studios sessions for promotional and educational purposes. By participating, you grant Roaming Studios permission to use images or video in which you may appear across our website, social media and marketing materials.

If you prefer not to be photographed or filmed, please let us know before your session begins. We will respect your wishes.

11. Participant Information

You agree to provide accurate booking information, including emergency contacts, dietary requirements, allergies, accessibility needs and any information that may affect your participation.

Our sessions may include walking, stairs, uneven surfaces, cobbled streets, bicycle riding and local transport. Participants are responsible for ensuring they are fit to participate. Make sure your travel insurance covers your personal requirements.

12. Travel Documents

You are responsible for obtaining all required travel documents, including passports, visas and any health or entry requirements. Roaming Studios is not responsible for costs resulting from missing or invalid travel documents.

13. Travel Insurance

Comprehensive travel insurance is mandatory.

Your policy should include cancellation cover, overseas medical expenses, personal belongings and travel delays. Proof of insurance must be provided at least 60 days before your session.

14. Session Changes

Every Roaming Studios' session is thoughtfully planned, but travel is unpredictable. To ensure the best possible session, we may make reasonable changes to the schedule, venues, workshops, artists, hosts or planning due to weather, local conditions, safety, availability or other circumstances beyond our control. Where possible, any changes will be replaced by comparable quality and value. Changes to tutors, artists, hosts or guides will not be considered grounds for cancellation or refund.

15. Acceptance

By paying your deposit and confirming your booking, you acknowledge that you have read, understood and agreed to these Terms & Conditions.
